Thank you! Now just recently passed as well is the National Convention in Oklahoma City. There is no way in my comparatively brief article to fully share all that took place. Our National website has good coverage in the blog at the "Latest News" link at www.napus.org. Meanwhile, "community letters" are going to the customers of vacant offices that are being reduced under POStPlan. At this point, there are no communities in Washington that have letters going out to them asking them, basically, if they do want a Post

Office (as opposed to the alternatives of VPO or carrier delivery), and if they do, what hours would they like. There will be no entertainment of increasing hours over the POStPlan-determined number of hours. The timeframe from mailing the letter to the date the newly-reduced office is officially managed by its Associate Office (AO) can be as little as two months; conceivably there could be Remotely Managed Post Offices (RMPOs) before Christmas. 2 NAPUS and League Postmasters are continuing to work on a detailed plan of what work is assigned to the AOs and what work is assigned to the RMPOs. A good rule of thumb seems to be if one doesn't have to physically be there to do it (i.e. myPO, eFlash, eMoves, ordering stamps) then the AO will have the responsibility for doing so for the RMPO. Also in Oklahoma City came the big push for the 2013 National Convention in Bellevue. How amazing to have it here! Angie Hawley, Convention Chair, and her committee are working hard planning an awesome convention for a 1000 or so of our closest friends to attend next August. Contact Angie to ask her how YOU can help; if you've never been to a National Convention this will be a perfect opportunity to see what so many are always raving about, without having to spend a lot of time or money travelling. Prior to my federal employment I had a choice. I had been offered two jobs one with Boeing and one with the Post Office Department. Yes it was before 1971. One offered a higher starting pay and full-time employment. The other was part-time with a flexible hours and a lower wage. I chose the one where I had never seen a picket line.

Through the years and many changes I was active in my union and eventually management organizations eventually ending my career with more than 20 years as a member of NAPUS. During my nearly 35 year career I did not give much thought to my benefits. I believed that much like a contract to purchase

a home as long as I made all the house payments fully and on time at the end of term I would hold title to my home. Similarity, I believed my benefits were something I earned paid for and somehow a contract that was inviolate. It was not an entitlement.

One has to do nothing more than read a paper or listen to the national news to be given a bleak picture of the US economy and our current financial condition. The interesting part is the variety of solutions offered. Federal active and retired employee wages and benefits are the first target. The suggestion to reduce or freeze wages, decrease benefits, increase benefit costs (including health and retirement) lengthen the number of years before retirement have all been offered. One suggestion included increasing employee retirement contributions to cover maintaining the low interest students pay on their federal student loans. Not all Americans – just active and retired federal employees.

Worst of all the U S Postal Service suggested its employees be removed from the FEHB, CSRS and FERS and moved to "new"

programs created for their active and retired employees. Just how is that going to work when they funds the employees have/had paid to that point are in the hands of OPM with no method for refund. Do you really believe they can create a program for more than one million active and retire employee zero \$\$\$\$ in a brand new account?

Federal active and retired seem to have a huge red target painted on their chest.... but USPS employees have two. One painted by Congress and the other one by USPS Headquarters. It is possible? Could the benefits I worked, earned and paid for be taken away from me. The short answer is YES!

So that you do not miss one very important point.....With the stroke of a pen Congress can change, reduce or eliminate the retirement and health benefits for both active and retired employees. You have no guarantees even after retirement that your earned not entitled benefits will remain. Additionally, many in Congress identify our earned and paid for benefits as some unpaid for federal entitlement program.

In looking for answers concerning my benefits I discovered that while I thought I was doing the right thing by belonging to Postal employee organization during my career I had overlooked the organization that since 1912 has been working to preserve, protect and enhance the earned wages and benefits of retired and active federal employees. The organization with this single purpose is the National Active and Retired Federal Employee Association - NARFE.

Currently I am the Treasurer of NARFE Chapter #163 but more importantly I have volunteered to speak to any active or retired employee organization or individual on NARFE's behalf. It is my belief that all active employees need to receive the urgent message of the threat to our earned benefits.

All active and retired employees need to join NARFE to add your voice to choir of 300,000 members of NARFE that speak to Congress on your behalf. The threat is real and we need to remind Congress of our contributions to this nation but financial and personal. To that purpose the cover story for this month's issue of NARFE magazine is entitled "The Federal-Postal Coalition Launches America Counts on Us". www.narfe.org

Think about the daily costs of your retirement and health benefits. Are they worth 12 cents per day? The cost of NARFE membership is \$45 per year...12 cents per day. For me it's the best investment I have ever made.

I am sincerely frightened. Many of us do not have the financial resources outside our federal retirement and health benefits to take us through to our final days. I hope you will join NARFE and help protect and preserve our present and future.

I think everyone loved the chocolate fountain dessert. I did! The lunch was held at Pioneer Park in Ferndale where Chet Speziale founded

and maintained the Postal Museum. It was so good to see and it serves as an on-going tribute to Chet. (He was quite a guy.) Being at the park for lunch was the only time I got out of the Silver Reef Casino/Hotel. It was a fun venue, and the fresh air and sunshine did me good. It was very exciting to see my dear friend, Postmaster Retired Vic Rohret be named Postmaster of the Year! Vic is always ready and available to help NA-PUS and Postmasters and it was great to see him so recognized. Karol Kusunose served a dual role as NAPUS retiree and NARFE representative. Karol presents some darn good arguments for active and retired Postmasters to join NARFE. As Congress looks at balancing a really tough budget, they are looking at having federal employees, who are 2% of the national population, make up 30% of the \$320 billion budget shortfall! This would be accomplished by a great reduction of federal pay and benefits. Scary? Stay vigilant, please. Oh, how our Postal Service is changing. In my last article, I asked Retirees to stand ready to help communities save their local post offices. Well, we are no longer being asked to serve in this capacity. Instead of closing post offices, many are being reduced in level and hours of service. Who would have ever thought there would be no more level 11, 13 and 15 post offices! Smaller offices are being either reduced to level 2 (2 hrs/ day) or 4 (4 hrs/day) or 6 (6hrs/

day) or designated as level 18s! Those level 2s and 4s will not be run by Postmasters but by non-career employees! Level 6's will be part-time career. My-ohmy, it is hard to comprehend. It took NAPUS National President Bob Raposa a good hour to get all of this through my head. It is hoped that when the economy and the postal service - recover, the infrastructure will be in place and these office can grow back to sustaining a Postmaster and a higher level of service. Also want to be sure you all have heard that the law has been changed so that retired Postmasters may now work as PMRs with no penalty. The rate of pay is \$11.76 per hour. For many, the thought of going back to work is not enticing, but I believe there will be many who miss the community contact and will want this opportunity. And boy, do I believe the USPS will need these retirees! There is going to be another huge "brain drain" like we saw in '93. Of those 40 or so active postmasters at the convention more than a dozen are looking to retire on July 31st. Holy Cow! The ranks of retirees are swelling! We wish them all a wonderful new life. And to those postmasters remaining, I hope you are happy and successful wherever you land within this new Postal Service. I love Conventions. I always have the best time. I get to travel to new parts of the country with people I really enjoy. The hotels are beautiful and the food is wonderful. Retirees in Oklahoma City were very busy and learned a lot. Those in attendance were Mel and Char Williams, Karol Kusunose, Vic Rohret, Marjie Gallagher, Karen Lemmon, Jackie Gurr, and new retirees Osa Siegner and Tom Runyan. And me. Oklahoma was another great adventure and we learned a lot about what it will take to host next year's National Convention in Bellevue. I heard much about how the Postal Service is changing. Postmaster General Patrick Donahoe had a positive outlook on the future. He maintains there are opportunities to grow and I think he is right. It is NOT the beginning of the end! He noted that we may be going to 5 day mail delivery, but with 7 day parcel delivery. This tells us something about what's happening in the business world. The times, they are a-changin'. One unusual aspect of this last National Convention was that the RETIRED Postmasters actually outnumbered the ACTIVE Postmasters. How can that be? And what are the ramifications? So here is my take: Retired Postmasters, you are needed more than ever to step in and lend your expertise. Just as the USPS has been undergoing major changes, so will the NAPUS organization, and retirees are going to be counted on to take a larger leadership role. We have the skills, knowledge and time. All you recently retired, be sure to complete the 1187-Rs now. To file electronically, go to www.napus.org. At the top of

the page, click on join now. The middle of the page will show 1187 and 1187-R. Click 1187-R, complete and submit. Easy. However, current Postmasters who are not so active, YOU need to step up to the plate also. It is your employment and your future that is at stake here. The National NAPUS and the WA State chapter are both in need of new and energetic blood and you are that transfusion. Step up. There isn't much "district" NA-PUS activity on the eastern side of the state, but that shouldn't keep anyone from attending state meetings and accepting some responsibility. Here's a quote I picked up at convention, "United we stick, divided we are stuck!" Hey everyone, be sure to vote. And check out how your congressional candidates, especially incumbents, support federal employees. According to Bob Levi, NAPUS Dir. of Government Relations, the Senate passed S1789 largely because of NAPUS activism. But if the House doesn't support this bill, and if HR2309 were to pass instead, it could be catastrophic for the USPS. Vote wisely. Hurray for those retirees helping with the Sept. Rural Route Count. The pay may be less than \$12 an hour, but I bet it will be the most fun they ever had during a RR Count.





"I haven't been trained in that." "I don't know how." "No one has ever showed me how to do that." "I've never heard that before." "I don't have time." -- Sound familiar? We hear this all the time; we've even probably uttered similar things ourselves. Now I am the first to admit that the Postal Service doesn't have a good track record in the training department, especially the last few years. Personnel are being depleted at all levels of the Postal Service, from the top down to your level. However, the work load hasn't decreased, just the number of folks performing that work. One of the first things to go is always training. So we have two choices: We can lament the loss, sit back and moan and groan about it, bitch, wail and holler, or we can take it upon ourselves to do something about it. There are hundreds of resources out there, just waiting for you to access them (see my articles in the upcoming NAPUS Alaska Postmaster newsletter). There is one new resource that I want to address here; it is new, it is cool, and it is now available. John Galera, Postmaster (now

retired) from Pearl City, HI, has

been active in NAPUS for a long time, and is the National Chair of the Education and Development Committee. For quite some time now he has been working on what he calls the "Postmaster Survival Disk", a CD chock full of links, programs, forms, manuals, and articles on how to do just about everything a Postmaster needs to know or do in his/her office. Hundreds of these CD's have been given to Postmasters during training sessions the past few years. However, as we all know, not everyone makes it to a National Convention, much less partakes of the excellent training opportunities available there. Well, you have just run out of excuses! The program is now online at our website, http://www.napus. org/. There are only two require-

ments to access the THOU-SANDS of links, forms, manuals and articles on the site: One, you must have internet access (and since you are reading this, I know you do); and Two, you must be a NAPUS member. Here are step-by-step instructions for accessing the site: Log on to http://www.napus.org/ On the home page, on "NAPUS Knowledge Base Now Live", click on "On October 1, 2012..." Register by typing in your last name and your NAPUS membership number (the five-digit number on your Postmasters Gazette mailing label) the account information page, fill in the blanks click "Register Now" That's it. When you access the site, there is a search bar. Type in whatever you are interest-

Don't wait for them to help you, help yourself ed in, and the search engine will list all the links and references available on the site for that particular subject. For instance, I typed in "1412", and the site came back with over 300 different documents available addressing this topic. What an awesome resource! And, it is available ONLY for NAPUS members. So the next time you start vocalizing some of the phrases that opened this article, turn on your computer and, instead of waiting for 'them' to help 'you', help yourself!
